2.1 Ms Grimshaw raised the issue of her letter of complaint to Holly Lynn about what she felt were the unsatisfactorily, rushed proceedings resulting in items which she claimed were inaccurate .In particular she was not happy that accounts were audited by the partner of a accountancy firm who was a member of the Residents Association PL said that he had discussed the matter with Residents Involvement, who said that they had no objection and were happy to release the LTRA Grant. It was agreed that M Gillies would check the situation again.
